The 8-day standoff that started out on Christmas evening of 1999 ended with the release of 3 militants. One passenger was killed, and 17 have been injured. The new anti-hijack law also doles out demise penalty to hijackers for any loss of existence, inclusive of that of floor group of workers or security personnel. The in advance regulation offered death handiest upon the dying of hostages. The definition of hijacking, too, has been increased to include making a risk, attempts or abetment to dedicate the offence;

even folks who organize or direct someone else to commit the offence could be deemed hijackers underneath the brand new law. The 11th of September assaults have been a series of four coordinated terrorist assaults by using way of the Islamic terrorist institution al-Qaeda towards the US at the morning of Tuesday, 11th of September, 2001. The assaults killed 2,996 humans, injured over 6,000 others, and triggered as a minimum \$10 billion in infrastructure and assets damage. Additional human beings died of 9/11-associated most cancers and respiration sicknesses within the months and years following the attacks.

Four passenger airliners operated by means of essential U.S. Passenger commercial airlines, all of which departed from airports within the northeastern United States certain for California—had been hijacked by way of way of nineteen al-Qaeda terrorists. Two of the planes, American Airlines Flight eleven and United Airlines Flight one hundred seventy five, were crashed into the North and South towers, respectively, of the World Trade Center complicated in Lower Manhattan. Within an hour and 42mins, both 110-tale towers collapsed. The fourth aircraft, United Airlines Flight ninety three, was

Many closings, evacuations, and cancellations observed, out of recognize or fear of in addition assaults. On November 18, 2006, creation of One World Trade Center commenced on the World Trade Center website online. The building became officially opened on November 3, 2014. Memorial & Museum in New York City, the Pentagon Memorial in Arlington County, Virginia, and the Flight 93 National Memorial in a field in Stony Creek Township near Shanksville, Pennsylvania.

Background of the Research

1971 January 30 : An Indian Airlines plane on its way from Srinagar to Jammu become hijacked by way of Hashim Quereshi and Ashraf Quereshi of the JKLF, who took it to Lahore. Foreign Minister of Pakistan rushed to Lahore and met the hijacker. On February 1, he persuaded them to launch the group and passengers who had been then dispatched by using avenue to Amritsar. The Government of India sought permission of Pakistan to ship a replacement group to fly the aircraft lower back to India. Pakistan government denied the permission, and supplied petrol to the hijackers with which they torched the aircraft on Feb 2. From Lahore Airport the hijackers have been taken right into a procession as heroes. [4], [5]

1976 September 10: Indian airlines plane Boeing 737 was hijacked from Palam Airport Delhi through a group of six terrorists from Kashmir: Syed Abdul Hameed Dewani alongside, Syed M Rafique, M Ahsan Rathore, Abdul Rashid Malik, Ghulam Rasool and Khawaja Ghulam Nabi Itoo. To refuel the plane, they took permission from CAA Lahore airport in Pakistan to land and refuel. The hijackers were stuck in a trick during breakfast, being serving colourless tranquilliser with water. All six hijackers have been taken in

custody and the aircraft turned into sent returned to India with 83 passengers on board. 1978: Friends Bholanath Pandey and Devendra Pandey hijacked an Indian Airlines plane on a home flight. They demanded the release of opposition leader Indira Gandhi and the withdrawal of all of the cases in opposition to her son Sanjay Gandhi. They carried simplest toy weapons. After preserving 132 passengers hostage for a few hours, they surrendered within the presence of media. The Indian National Congress birthday celebration rewarded them with birthday party tickets for the 1980 kingdom meeting election; each gained the election and has become contributors of the legislative assembly of Uttar Pradesh. Bhola served as a Congress MLA from 1980 to 1985 and 1989 to 1991 from Doaba, Ballia and Devendra remained a member of the residence for 2 phrases. Devendra served the birthday celebration as a preferred secretary of Uttar Pradesh Congress Committee till recently. He is now nurturing the Sultanpur constituency within the hope of a Congress price tag inside the next elections.

1981 September 29: An Indian Airlines IC-423 plane on flight from Srinagar to Delhi emerge as hijacked with the aid of Sikh extremists to get appropriate rights from India and taken to Lahore. Pakistan took commando action the use of its elite SSG, which cleared the plane and freed all passengers.

1982 August 22: A lone militant, armed with a pistol and a hand grenade, hijacked a Boeing 737 on a scheduled flight from Bombay to New Delhi wearing 69 men and women. Indian safety forces killed the hijacker and rescued all passengers onboard.

1982 August: An Indian Airlines flight from Jodhpur to Delhi turned into hijacked. The hijacked aircraft landed at Amritsar.

1984 July 6 : An Indian Airlines jet sporting 255 passengers and a crew of 9 on flight from Srinagar to New Delhi changed into hijacked and pressured to land in Lahore, Pakistan. The hijackers were stated to be armed with pistols, daggers and explosives. The hijackers' surrender to Pakistani authorities ended a 17-hour ordeal for the plane's passengers and team, who remained aboard the A-three hundred Airbus in suffocating warm temperature, with little meals and water.

1984 August 24: Seven younger hijackers demanded an Indian Airlines jetliner, on a domestic flight from Chandigarh to Srinagar with a hundred passengers on board, be flown to the united states. The aircraft changed into taken to Lahore, Karachi and finally to Dubai in which the protection minister of UAE negotiated the discharge of the passengers. It became associated with the secessionist battle inside the Indian state of Punjab. The hijacker changed into eventually extradited via UAE authorities to India, who passed over the pistol recovered from the hijacker. Investigations found out that the pistol became synthetic in Germany and became a part of seventy five pistols consigned from Germany to CAO, PO Box 1040, Islamabad. The Pakistani Foreign Ministry denied the accusation.

1993 April 24: Indian Airlines aircraft sure for Srinagar thru Jammu from Delhi is hijacked. The hijacker wanted to take the plane to Lahore, but Pakistan authorities refused permission. The plane landed at Amritsar where the hijacker turned into killed and passengers freed.

1999 - 2000: Indian Airlines Flight 814, flying from Kathmandu, is hijacked and diverted to Kandahar. After per week-long stand-off, India concurs to launch three jailed

Kashmiri militants in alternate for the hostages. One hostage becomes stabbed to dying and his body thrown at the tarmac as a "warning assault".

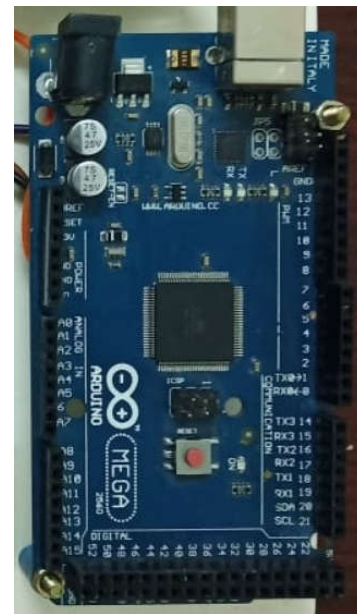
within the cockpit can swiftly spark off the safety tool to behave in opposition to the hijackers. In this way, the event of hijacking can be hastily removed before it receives worse.

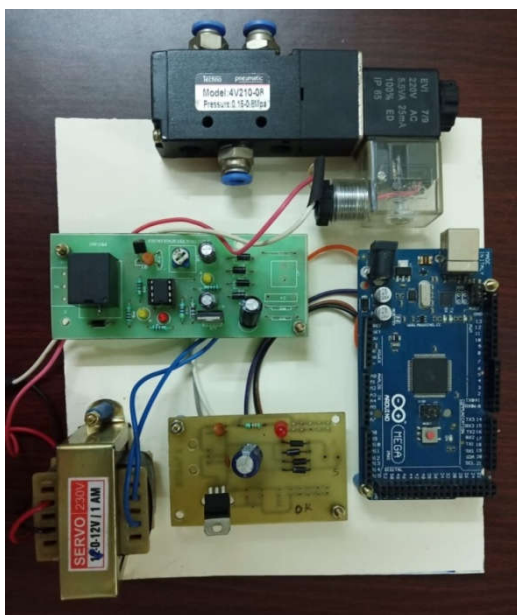

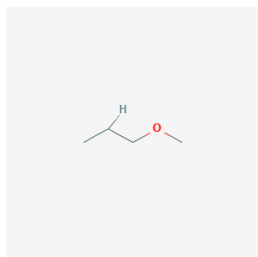
